

SAILING VESSEL SAFETY SURVEY PROCEDURE (COF)

1. Download the safety survey documents from the SA Sailing website, collect copies from FBYC reception, or ask reception to send you electronic copies (info@fbyc.co.za), including this procedure document. Please indicate the Category of your vessel when requesting the documents.
2. Make an appointment with one of the club Safety Officers listed below to survey your vessel.

3. Pay the relevant fees, as listed below. Please use your vessel name as the reference when paying electronically:

4. Once the survey has been completed, please provide FBYC reception with the following:
 - a) Proof of payment (hard copy) of the amount paid to SAS.
 - b) White copy from the Safety Officer's book.
 - c) 1st & 2nd pages of the completed SAMSA paperwork signed by Owner & Safety Officer.
 - d) Electronic photo of your boat.
5. FBYC reception will submit electronically to SAS once all the paperwork is received/correct. SAS will issue an electronic COF (valid for one year), sent to the owner's e-mail address (which is taken from the completed form so please ensure that this is clearly printed) and will be copied to FBYC for the records.

Important Note: In order to obtain your COF, your vessel must be registered in your name and you should be in possession of a Certificate of Listing. If not, please download the "Application for Vessel Listing" form, including the "Submissions with application for local vessel listing" from the SAS website <http://sailing.org.za> . (Hard copies are also available at FBYC Reception). See costs below:

FOR FBYC OFFICE PURPOSES:

If you have not already done so, please supply the club with the following documents for their records:

- Skipper's Name & Contact Details if not the owner of the vessel

Vessel Details:

- Copy of Registration/Listing Certificate
- Copy of Ship Station Radio Licence
- Copy of EPIRB Registration (if applicable)
- Copy of Life Raft Certificate (if applicable)

Skipper/Owner Details:

- Copy of Certificate of Competency
- Copy of Restricted Radio Operator's Certificate
- First Aid Certificate (if applicable)

NB. All the above information only needs to be submitted once, unless there is an expiry date. i.e. First Aid Certificate.
