SAILING VESSEL SAFETY SURVEY PROCEDURE (COF)

1. Log onto the SA Sailing website and follow the procedure as per the attached from SAS.
2. You will then receive an invoice from SAS with a reference number for payment. Once payment has been made to SAS, please keep a copy of the Proof of Payment as this needs to be sent to SAS along with your COF survey documents.
3. Make an appointment with one of the club Safety Officers listed below to survey your vessel.

5. Once the survey has been completed, please provide FBYC reception with the following:
 - a) Proof of payment of the amount paid to SAS.
 - b) Proof of payment of the R70 paid to FBYC.
 - c) White copy from the Safety Officer's book.
 - d) 1st & 2nd pages of the completed SAMSA paperwork signed by Owner & Safety Officer.
 - e) Electronic photo of your boat (if not provided previously).
5. FBYC reception will submit electronically to SAS once all the paperwork is received.
6. SAS will issue an electronic COF (valid for one year), sent to the owner's e-mail address and will be copied to FBYC for their records.
